Cities and nations around the world have nowadays introduced and promoted policy instruments as part of their economic growth policy to boost startup businesses in their territories. Some of those cities have grown into a *global* startup city. Global startup cities have attracted many advanced entrepreneurs from various regions in the world, while also having successfully developed "indigenous" entrepreneurs with strong mindsets for the global market. Startups created by those entrepreneurs have attracted investments internationally as well as domestically. An increasing number of those startups have grown to have developed cutting-edge technologies, and have successfully penetrated into the global market.

What key factors have existed behind the rise of those cities (or nations) as a global startup city (or nation) in this regard? What should be done to maintain and expand the strengths of those cities (or nations)? How can a global startup city be created in Japan?

In this event, **five distinguished speakers** will discuss these questions from various angles, while being based on their visions and experiences and referring to Silicon Valley in the U.S., Israel, and Estonia as examples of everexpanding global startup cities (or nations) as well as to two Japanese cities - City of Fukuoka and City of Tsukuba - that are aiming to be a global startup city.

**Noa Asher** Economic Minister Head of Economic and Trade Mission Embassy of Israel, Tokyo

Noa Asher has been appointed as the Economic Minister as a Head of Economic and Trade Mission at the Israeli Embassy in Tokyo from September 2014. As such she will be responsible for initiating and maintaining trade relationships between Israel and Japan.

Before moving to Tokyo, Noa was the Head of the International Support and Finance Department, at the Foreign Trade Administration of the Israeli Ministry of Economy assisting Israeli companies in penetrating International markets and managing governmental support funds.

Between 2006-2010, Noa served as Israel's Economic Consul to the US Midwest where she focused on initiating collaboration opportunities between Israeli and American companies especially in the Life Science and Cleantech sectors.

Previously, Noa served as the Chief of Staff for the Chief Scientist of the Ministry of Economy. She joined the ministry in 2002, serving as a Foreign Trade Officer within the Asia Pacific Division of the Foreign Trade Administration. Prior to entering government service, Noa was a legal advisor to an Israeli group of start-up technology companies.

Noa holds an MPA from John F. Kennedy School of Government at Harvard University, an MBA from Tel Aviv University and an LLB degree from the Hebrew University of Jerusalem.

At the same time, he joined Fukuoka D.C. (Fukuoka Directive Council), which is the organization that has been operated under the partnership of industry, government and academia in Fukuoka City for providing policy advisory services regarding industry development in the city. He is now a Senior Manager at Fukuoka D.C., and has served as a consultant for startup companies in the city, while contributing to expanding the network of Fukuoka City's startup ecosystem with other countries.

Since 2018, he has been a Visiting Associate Professor at the Department of Academic Research & Industry-Academia-Government Collaboration of Nagoya University. He has also been a member of the Advisory Board for Innovation Leaders Summit.

## **Toru Kodama** Associate Professor, University of Tsukuba Associate Economist, Institute for International Trade and Investment

Before joining the University of Tsukuba, Toru Kodama held various posts in industry, academia and government. For example, he previously worked as a legal and investment officer for Dentsu, one of the world's largest advertising agencies, and as a policy analyst for the Office of Science and Innovation at the Swedish Embassy in Tokyo. He was also a full time associate professor in the field of intellectual property law and creative industries at Kyushu University and a visiting scholar at Columbia University School of Law. He has been an associate economist at the Institute for International Trade and Investment since 2014.

Toru received a B.Eng. degree from Tokyo Metropolitan University and a M.A. degree in International Public Policy from Osaka University. And, after completing the Postgraduate Diploma in Law Course at the University of Exeter and the Bar Vocational Course at BPP Law School, he was Called to the Bar by the Middle Temple in London.
